RE: Institute of Alcohol Studies response to Working Group on Regulating Sponsorship by Alcohol Companies of Major Sporting Events consultation

The Institute of Alcohol Studies (IAS) is grateful for the opportunity to comment on the proposals outlined by the Republic of Ireland's Working Group on Regulating Sponsorship by Alcohol Companies of Major Sporting Events. IAS is an independent charity that aims to bridge the gap between the scientific evidence on alcohol and the wider public. We advocate for effective, evidence-based public policy responses that will reduce the toll of alcohol in society.

IAS strongly endorses the consultation submission made by Alcohol Action Ireland (see appendix 1). We support the recommendations outlined in this submission, including its advocacy for a ban on sports sponsorship by alcohol brands in the Republic of Ireland:

'A ban on alcohol brands' sponsorship of sports should be legislated for, with an implementation date of six years hence to allow alternative arrangements to be made by sporting organisations to replace sponsorship income. In the intervening period no further alcohol industry sponsorship of sport should be permitted.'1


